我们审计了后附的海南天然橡胶产业集团股份有限公司(以下简称“海南橡胶”)按备考财务报表附注(二)披露的编制基础编制的备考财务报表,包括 2016 年 6 月 30 日、2015 年 12 月 31 日、2014 年 12 月 31 日的备考合并资产负债表和 2016 年 1-6 月、2015 年度、2014 年度的备考合并利润表,以及备考财务报表附注。

## 一、管理层对备考财务报表的责任

编制和公允列报备考财务报表是海南橡胶管理层的责任。这种责任包括:(1)按照备考财务报表附注(二)所述的编制基础编制备考财务报表,并使其实现公允反映;(2)设计、执行和维护必要的内部控制,以使备考财务报表不存在由于舞弊或错误导致的重大错报。

## 二、注册会计师的责任

我们的责任是在执行审计工作的基础上对备考财务报表发表审计意见。我们按照中国注册会计师审计准则的规定执行了审计工作。中国注册会计师审计准则要求我们遵守中国注册会计师职业道德守则,计划和执行审计工作以对备考财务报表是否不存在重大错报获取合理保证。

审计工作涉及实施审计程序,以获取有关备考财务报表金额和披露的审计证据。选择的审计程序取决于注册会计师的判断,包括对由于舞弊或错误导致的备考财务报表重大错报风险的评估。在进行风险评估时,注册会计师考虑与备考财务报表编制和公允列报相关的内部控制,以设计恰当的审计程序,但目的并非对内部控制的有效性发表意见。审计工作还包括评价管理层选用会计政策的恰当性和作出会计估计的合理性,以及评价备考财务报表的总体列报。

我们相信,我们获取的审计证据是充分、适当的,为发表审计意见提供了基础。

### 三、审计意见

我们认为，海南橡胶备考财务报表在符合财政部《企业会计准则》等财务报表附注（二）的规定编制，公允反映了海南橡胶2015年12月31日、2014年12月31日的备考合并财务状况以及2015年1-6月、2015年度、2014年度的备考合并经营成果。

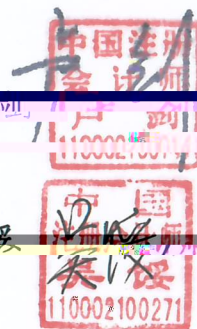
### 四、其他说明
